<u>Subject</u>: Conduct of Nation-wide Pay & Allowances (*VETAN-BHATTA*) Adalat to be held in the last week of Februrary, 2021 reg.-

Madam/Sir,

With reference to the subject cited above, it has been decided by the Competent Authority of KVS that all the Regional Offices/ZIETs may conduct the VETAN-BHATTA Adalat in the last week of February 2021 through Digital Technology only.
